PRIVACY OF PERSONAL DATA (13 - D.Decree 196/03)

The company We Do srl with registered office in Via Giovanni Pascoli 4 – 06081 Assisi (Pg), as owner of the treatment in the person of its legal representative pro tempore makes to its customers and suppliers the information on the processing of personal data pursuant to art. 13 D. Decree No 196/03 on the protection of personal data.

Please note that, for the establishment and / or execution of the current contractual relationship with you, our organization is in possession give information relating to you, acquired also orally, directly or through third parties, qualified as "personal data" by D. Decree No 196/03.

The legislation in question are, first, that whoever performs processing of personal data must inform the data subject about which data are handled and some concerning the processing, which, however, must be treated fairly, lawfully and transparently, protecting your privacy and your rights.

In case of treatments not covered by the following statement, it will be the Data Controller to provide appropriate and comprehensive information to stakeholders including oral on these treatments.

Therefore, according to art. 13 of Legislative Decree no. 196/03, we provide the following information:

Type of data treated

We treat your personal details and tax, as well as the economic data that are necessary for the performance of contractual relationships with your organization or to manage the earlier phases of the contract. We are not in possession of any data deemed sensitive or judicial nature in art. 4, paragraph 1, of Legislative Decree No 196/03.

Aims of treatment

Your data will be processed in accordance with contractual requirements and for the fulfillment of legal and fiscal obligations, and to enable effective management of financial and commercial and / or respond to your specific requests in the pre-contract.

The data will be processed for the entire duration of the contract and then, for the fulfillment of legal obligations and for administrative and commercial purposes.

In case the negotiations carried out in the pre-contract not produce a favorable outcome your data will be kept and stored for possible use at a later date for further contact and/or offers.

Processing methods

The data will be processed through the use of tools and procedures to ensure the security and confidentiality and can be made either by paper, either through electronic means.

Communication and dissemination

Your details will not be "disclosed", this being intended to give knowledge to unspecified third parties in any way, including by making available for consultation.

Your data may instead be "communicated", this being intended to give knowledge to one or more subjects, as follows:

- § subjects appointed in the manner provided by law, within our organization to process your personal data;
- § subjects which can access the data under provisions of the law, regulation or legislation, within the limits set by these rules;
- § Individuals who need to access your data for purposes ancillary to the relationship between you and us, to the extent strictly necessary to accomplish the tasks assigned to them (for example: banks and freight forwarders);
- § to our consultants, to the extent necessary to carry out their duties in our organization, subject to our letter of assignment that imposes a duty of confidentiality and security in the processing of your data.

Your rights

You have the right at any time to obtain confirmation of the existence of the data and to know their content and origin, verify its accuracy or request its integration or updating or rectification (Art. 7 Legislative Decree no. 196/03). Pursuant to this Article shall have the right to request cancellation, transformation into anonymous form or blocking of data treated in violation of the law, and to oppose in any case, for legitimate reasons, their treatment.
